## Updates from Executive Director

- Informed Commissioners to reach out to Commission Staff with any bills that could directly or indirectly affect LGBTQ Community.
- Making sure Commissioners keep meetings outside of official meetings below 8 members to avoid unintentional quorum
- Primary role of Commissioners: Community representation
- Outreach to the Community has so far included King, Pierce, and Thurston Counties
- Would like to put emphasis on rural communities, example, not just Yakima, rural towns in the area as well.

  - o LGBTQ Panic Defense Bill, working on having a signing for the bill



- Commission has had 2 official events
  - Pink Caucus event recognizing the Commission
  - Outreach event co-sponsored with the Women's Commission
    - Over 100 people attended event
    - Celebrated Speaker Jinkins
- Staff has...
  - o met with legislators, and other colleagues
  - Taken all kinds of trainings
  - Have met with all members of LGBTQ Caucus plus LGBTQ member of the house that is not a part of the Caucus

## Queries by Commissioners:

- Will Commissioners be given Commission emails?
  - Response: Staff is working on having site and domain built, access to Commission emails will be looked into. Things to consider include additional cost for emails
- Question regarding testifying. Difference between testifying on behalf of the Commission or as a private citizen
- Question regarding compensation of community members brought onto committee.
  - Response: Would be better question to pose to the Director of Commissions
- O Question: Are we taking into account hiring/outsourcing to members of the community or other minority groups?
  - Response: We are limited but do use LGBTQ or minority groups as we can
- O Question: Do other organizations ask for ASL services?
  - Question was in regards to the fact that we were not successful in getting ASL interpreters
- Question regarding donations
  - Limited by statute: we cannot solicit donations, but if donations are offered we can accept them
  - We can apply for grants
- Question regarding minutes
  - Minutes have to made public when asked. Most agencies post minutes on their website in the interest of transparency
- Question regarding public comment
  - Public comment is actually not required

Commissioner Robinson noted their concern about having a co-chair system in regards to splitting responsibility among the co-chairs Commissioner Honnen noted "we don't need to operate under the system we are currently under"

Commissioner Yarce noted their approval of the co-chair model Commissioner Landers commented that co-chairs should have staggering appointment expirations

Commissioner Archer supports co-chair model with the Commissioner Landers recommendations for staggered appointment expirations Commissioner Goldsen commented that co-chairs should have slightly different roles, supports co-chair model

Commissioner Hill-Meyer offered having a 4<sup>th</sup> executive committee member

Motion (Commissioner Griffith): To strike article 4, section one, replace with "the officers of the commission shall be the two co-chairs, vice chair, and the secretary "all following sections in by-laws will reflect" article 1 and 2, terms of office, article 5 section 3, article 6 section 1 "commissioner co chair duties add line g, co chairs agree within first 30 days after election on the division of their duties, duties will be written for review by the body" article 4 section 2 "shall be elected annually by commission, with the exception that in the first year of the commission one co chairs term will last for two years and one co chair's term will last for one year.
